- When using Adobe Acrobat, clicking on the URL will connect you directly to the website and avoids wading through sometimes convoluted state websites to find the information you're looking for.
- Knowing the party affiliation and when the Attorney General took office can also be beneficial if you are doing business in a particular state or involved in state politics.
